## EXTENSION OF QUARANTINE APPLICATION

The Wyoming Livestock Board Office must receive **one application per lot of cattle quarantined.** **DO NOT ASSUME** the extension will be granted automatically. The quarantined cattle shall remain separate and apart from other cattle and shall not commingle with any other livestock.

*A Producer may apply for a quarantine extension only if the livestock are coming from a Brucellosis Free State.*

**NOTE: Application must be completely and accurately filled out for approval.**
