Do not wait until you are ready to brand before submitting application. Brands must be registered with this office to be a valid Wyoming brand. Allow 2 to 5 days for application processing.

FEES

Fees must be submitted at the time of application, we accept cash, check, money orders, Visa, Mastercard, and Discover. Credit card payments can be made by calling the office.

- ➤ All abandoned brands are \$400.00 regardless of how many species.
- In the event a brand is not recorded you may request a refund, a percentage of the application fee shall be refunded.

LEGAL RECORDING ON APPLICATION

If the brand is to be re-recorded in more than one name, please indicate if it is:

- > HUSBAND AND WIFE (with right of survivorship)
- > JOINT TENANCY (with right of survivorship)
- > TENANTS IN COMMON (without right of survivorship)
- > PARTENERSHIP (other than a limited or registered limited partnership, applicant must list on the application all partners and agents authorized to act on behalf of the partnership)
