This order rescinds the Emergency Order Evacuation of Livestock Due to the House Draw, Remington, Flat Rock and Constitution Fires (Order # WLSBEM2024-01) dated August 26, 2024.

Order #WLSBEM2024-02

On August 26, 2024, Steve True, Director and CEO of the Wyoming Livestock Board, announced an emergency order based on W.S. § 11-20-203(d) for Johnson County (House Draw fire), Sheridan County (Remington fire) and Campbell County (Flat Rock and Constitution Fires). Effective as of September 11, 2024, Director True rescinds Emergency Order #WLSBEM2024-01, making it no longer in effect.

All livestock moved pursuant to Emergency Order #WLSBEM2024-01 will require an ownership brand inspection before returning to the affected area after the incident or moving to an additional destination if unable to return home. This inspection will be a complimentary inspection.

*****EMERGENCY ORDER*****

Dated: August 26, 2024

Evacuation of Livestock Due to the House Draw, Remington, Flat Rock and Constitution Fires.

Order #WLSBEM2024-01

Steve True, Director and CEO of the Wyoming Livestock Board has announced an emergency order based on W.S. § 11-20-203(d) for Johnson County (House Draw fire), Sheridan County (Remington fire) and Campbell County (Flat Rock and Constitution Fires) allowing the movement of livestock without Brand Inspection from the evacuation area to neighboring counties in Wyoming. The emergency order will only apply to livestock producers/owners identified as in immediate or imminent danger, or under voluntary evacuations as determined by the Incident Commander.

The affected area is for all residents along the active area of the House Draw Fire in Johnson County, Remington fire in Sheridan County, and Flat Rock and Constitution Fire in Campbell County. This emergency order was made with the coordination of the on-scene Incident Commander.


Livestock producers/owners wishing to move their livestock in a prevention effort requires full compliance with all regular brand inspection/health inspection requirements. This order is **NOT** for previously planned transportation, movement to different pastures, or change of ownership. This announcement is only for the emergency and temporary evacuation of livestock in the affected area. Anyone moving livestock as result of this order are required to notify a Brand Inspection District Supervisor or a local Brand Inspector within 48 hours after the livestock movement.

If evacuation movement plans require livestock to cross State lines, please call the Wyoming Livestock Board for additional information.

This order begins **August 26, 2024** and remains in effect until a written announcement is made by the Wyoming Livestock Board.

All livestock will require an ownership brand inspection before returning to the affected area after the incident or moving to an additional destination if unable to return home. This inspection will be a complimentary inspection.
